.....OVER TO THE LIBERAL/NATIONAL COALITION GOVERNMENT

We must learn from Ku-ring-gai that getting density right is entirely a matter of execution. Medium density can be as brutal and destructive as a six storey Ku-ring-gai "egg crate" or as graceful and enduring as a Paddington terrace house. Architectural history teaches us that there are many building typologies — including terrace houses, semi-detached dwellings and Miesian courtyard houses — which increase density while maintaining and even improving the natural environment. It is a disgrace that increased density has been treated by planners as a kind of cod liver oil to be forced on local communities regardless of their situation. Houses should not be off the rack commodities, designed for the ideal consumer.







Examples of Ku-ring-gai densification that actually look like homes, respect the context & have architectural merit.

The numbers and targets which underpin calls for increased density are not sufficiently rigorous. Typically far more of an area than is necessary to achieve a "target" is rezoned, with extremely messy results. In my experience the methodology behind this 'over-zoning' is extremely rubbery if not entirely arbitrary. Rather than insensitively rezoning existing neighbourhoods, densities should be increased in precise, circumscribed areas, such as former industrial sites, where redevelopment will improve the city. The sensibility of the urban designer, who designs streets and public spaces, needs to take precedence over that of the planner, who colours in blocks on a map according to the demands of a spreadsheet. Public confidence in the concept of increased residential density has been, with good reason, shattered."

HERITAGE CONSERVATION AREAS (HCAs)

Ku-ring-gai is virtually the only Local Government Area in NSW not to have HCAs in place prior to urban densification. The blame lies significantly in the refusal of successive past Labor State Planning Ministers to gazette Ku-ring-gai's HCAs. Despite Ku-ring-gai being of national significance for its tree canopy, its built, cultural and natural environment, its outstanding 20th century housing and the evidence it provides of 20th century town planning and conservation philosophies, intense densification has been able to occur disregarding all of these features. The few HCAs established as part of the Town Centres Plan are inadequate.

This dire situation caused the Australian Council of National Trusts to place areas of Ku-ring-gai (National Trust-Identified) on its 2009 List of Australia's Top Ten Heritage Places at Risk. The listing described the threat as:

Loss of settings and entire garden streetscapes; loss of trees and bushland; demolition of many individual outstanding heritage homes and replacement by six-storey apartment blocks and loss of community under insensitive development and unsympathetic rezonings.

The fate/outcome was listed as: Strongly suffering. Ku-ring-gai's heritage is being smashed and shattered.

Given the significance of the National Trust-Identified Areas, FOKE is most concerned that only 7 of the National Trust-Identified Areas are included in Council's current "Heritage Conservation Area Review North". With the exception of Council Areas 23, 25, 27 and 28, the National Trust-Identified Areas in the north are greatly reduced or not recognised at all, leaving these National Trust-Identified Areas exceedingly vulnerable and exposed to more unsympathetic infill development and to gross and inappropriate development. This is unacceptable. While some people may believe that HCA controls are an extra level of interference by councils, studies have shown that HCA controls lead to increased amenity and enhanced property values. FOKE strongly supports HCAs.

"Conservation and development are not mutually exclusive objectives; they should, and can, be part of single planning process. Conservation projects need provision for development just as surely as competent development requires an adequate approach to determining conservation policy. Developments do not take place in a vacuum but an existing place, in existing surroundings. This seemingly obvious fact has to be understood and accepted before decisions on the relationship of conservation and development can be made."

UNLIMITED GROWTH? CAP ON POPULATION IN CITIES?

An article published in the Sydney Morning Herald 29.3.2011 reported Prime Minister Gillard's opinion that some of Australia's most densely populated areas have reached their "carrying capacity." The article's heading "Cap on population in cities could slash the value of houses" represents the opinion of the Urban Task Force Australia. In response we reprint the following letter from the "Letters to the Editor" page.

The People Power report from Urban Taskforce Australia ("Cap on population in cities could slash the value of houses", March 29) is typical of that organisation's focus on the short-term business interests of its members while ignoring the longer-term well-being of the wider community.

It ignores the fact there cannot be infinite growth in a finite world and that growth must stop eventually. It commits the error of assuming that because past growth has been necessary, then continuing growth is the only acceptable future, and it pays no heed to the fact that our capitalistic system is wonderfully adaptable. Further, it fails to recognise that should the construction industry diminish in size then many young people now becoming trades people and building professionals will be available to work in more socially redeeming fields than covering our best farmland with concrete slabs.

At current rates of growth, Sydney will have 9 million people in another 50 years, 18 million in 100 years and 36 million in 150 years. That is the future the Urban Taskforce has in store for us. It should be seen for what it is; a lobby group promoting narrow short-term business interests.
