Ku-ring-gai Fights Back

FOKE endorses Ku-ring-gai Council's call for the immediate withdrawal of the Minns Government's planning 'reforms' and that genuine consultation begins with NSW councils and their communities.

Ku-ring-gai Council Extraordinary meeting of 29 January, 2024 condemned "the State Government for its irresponsible approach to planning for the future of the built and natural environment of NSW".

NSW's Planning 'reforms' are undemocratic and undermine the entire NSW Planning system. They effectively hand over planning controls to developers.

Massive rezonings are planned across Greater Sydney, the Central Coast, Lower Hunter, Greater Newcastle & Illawarra-Shoalhaven.

The rezonings depend on one-size-fits-all-cookie-cutter planning policies — distance from a railway station and/or shopping centre. This will destroy Sydney's unique character, environment and heritage. No suburb is safe.

Nor will the mid-to-high rise apartments be affordable, of quality design, or well constructed.

The costs to NSW in providing the infrastructure to service the additional population is prohibitive. Where will the money come from to fund the additional schools, hospitals, ambulances and other services needed for such a huge population increase? No economic analysis has been provided. There are real fears that the



plans will overwhelm NSW's services and push NSW into bankruptcy.

April Fools' Day, the 1st April, is expected to be the day the NSW Government introduces its first round of rezonings—Transport Orientated Development (TODs) that rezone 400 metres around Roseville, Lindfield, Killara, Gordon Railway Stations. This will wipe out Ku-ring-gai's Heritage Conservation Areas and wildlife corridors. The evidence justifying this destruction remains secret as 'Cabinet in Confidence'.

FOKE has met with local MPs—Matt Cross (Davidson), Alister Henskens (Wahroonga), and Paul

Fletcher (Federal MP for Bradfield) as well as Ku-ring-gai Council's Acting General Manager David Marshall, staff and other community leaders.

FOKE thanks Alister Henskens SC MP for 'blowing the whistle' about a senior NSW Planning bureaucrat who purchased a property allegedly knowing that it was going to be upzoned for higher profits. This matter has been referred to the Independent Commission Against Corruption (ICAC).

FOKE is calling on Shadow Premier Mark Speakman to reject the planning proposals if elected to government. The Minns Government

PRESIDENT'S MESSAGE

Dear Members

What a start to 2024!

Before we could really enjoy the Christmas and January school holidays the Minns State Government released one of the most alarming and autocratic changes to NSW Planning in NSW that we have experienced.

The Minns Housing Plan is breaking down the NSW Planning System as we know it.

Every Ku-ring-gai suburb will be affected. Roseville, Lindfield, Killara & Gordon will have 6-7 storey apartments (8-10 with affordable housing components) within 400 metres of the railway station. Other Ku-ring-gai suburbs will have units blocks ranging from 2-6 storey in the form of manor houses, duplexes, town houses and dual occupancy which will allow 4 houses on a block size of 900sqm. The only homes spared of Minns' proposals is land zoned C4 (high bushfire prone land).

The Minns Housing Plan is not based on sound strategic planning principles: The plans allow:

- Dual occupancies (two dwellings on the same lot) in all low-density residential zones, with a minimum lot size of 450 square metres.
- Affordable housing bonuses of up to 30% for floor space ratio and height, on top of the proposed new controls.
- Overriding existing planning controls, such as those for heritage and environment.
- Introduction of 'non-refusal standards' for the new planning controls by which development consent may not be refused.
- Impacts on heritage, trees, biodiversity, traffic and stormwater, and significant tree loss.

- No consideration given to the necessary infrastructure to support density such as schools, transport and community facilities;
- The proposed new planning controls to apply in Heritage Conservation Areas - the NSW Government has stated it will result in significant changes in these locations.
- These new controls will override the existing controls in Local Environmental Plans and Development Control Plans e.g. heritage and environmental considerations.

Ku-ring-gai has significantly exceeded its housing targets (2004-2031) by approximately 60% and has capacity within the current Local Environment Plan to plan to allow for a further 3000- 5000 dwellings to 2026 (set by the now defunct Greater Sydney Commission).

FOKE has with the assistance of members and volunteers letterboxed 17,000 FOKE flyers, distributed FOKE posters on A-Frames and front fences, including handing out FOKE flyers at Gordon Markets and the Council Information Session.

FOKE is now planning a **Save Greater Sydney Coalition Rally** with groups across Sydney and the regions for **Tuesday 12 March commencing 1.00 pm at the 'Tree of Knowledge' directly behind Parliament House in the Domain.** We hope all members will join us at the Rally with your placards.

FOKE's 30th Anniversary will be celebrated this year with its details still to be arranged.

is a minority government.

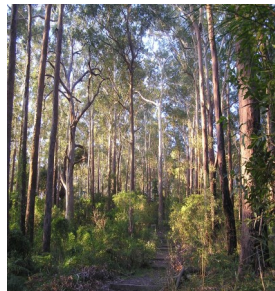

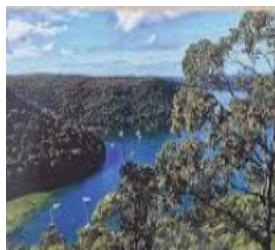

Stop Vandalism of Trees

FOKE is encouraging members to sign the [online NSW Legislative Assembly ePetition](#) to increase penalties for urban forest tree vandalism and recognize trees as Natural Assets in the Integrated Planning & Reporting Framework of The Local Government Act.

In November 2023, Lane Cove witnessed the worst act of environmental vandalism in its history. Nearly 300 trees and plants were illegally removed from Council-owned bushland in Longueville.

FOKE is constantly being contacted by residents concerned about tree removals in Ku-ring-gai.

Local governments received more than 1000+ reports of trees being damaged or killed in the previous 12 months.

Current fines for tree vandalism in NSW are paltry compared to ACT's fines of up to \$80,000.

Minns' Wrecking Ball

If implemented there will be:

- Loss of tree canopy & wildlife
- Loss to heritage & character
- Strain on existing infrastructure & facilities
- Traffic gridlock

Together they will destroy NSW's built, natural and cultural heritage and:

- contravenes the *Environmental Planning and Assessment Act 1979 (EPA&A)* and other NSW environmental & heritage legislation
- will **not** deliver housing affordability
- is undemocratic
- is 'corruption prone'

Lourdes Planning Proposal Unanimously Rejected

The Lourdes Planning Proposal to upzone the site to a vertical six storey retirement village and allow 63 non-seniors townhouses on the bushfire flame zone in Stanhope Road Killara, was refused by the Sydney North Planning Panel.

The decision made by the SNPP five-member panel on 15 December 2023, was unanimous.

The Gateway determination alteration is to be submitted to the Department of Planning and Environment requesting the proposal no longer proceed.

The Panel Hearing heard presentations including from Ku-ring-gai Council, FOKE, Step Inc, residents of Lourdes Retirement Village, Killara neighbours and members of the public who had submitted objections to the planning proposal.

Levande, the new owner of the Lourdes spoke in support of the proposal and one resident. The submissions to the SNPP included objections in relating to the changes in zoning from R2 to R3, scale, density, building height, management of bushfire risk, ecology and related transport issues.

The SNPP thankfully found that the proposal did not warrant the support to proceed and should not be made:

Key issues being:

- Bushfire risks and density distribution
- The Panel was not convinced of the proposed solution of a Special Fire Protection Facility (SFPF) being either appropriate or effective as opposed to an Asset Protection Zone.

- The erection, and sale of townhouses to the general population which could still be housed by seniors with the same dependencies and accessibility issues.
- An unacceptable bushfire risk to residents of the likely age and fragility.
- The introduction of a C2 Environmental Conservation Zone could increase bushfire risk thus being a conflicting constraint.
- Not an appropriate balance between neighbour amenity and distribution of density in the form of 6 storey development abutting existing R2 single residential.
